All application materials must be submitted or returned to the Whitefish Bay Recreation Department no later than Friday, April 5th, 2024.

Requirements:

- 1) Bay Volunteer Applicant must be in or entering High School in Fall 2024.
- 2) Bay Volunteer Applicant should volunteer 5 consecutive days each week they select.
- 3) Bay Volunteer Applicant must attend the scheduled volunteer training session that will take place the week of June 17th, 2024 (details TBD).
- 4) Bay Volunteer Applicants who have never volunteered for us before must participate in a group interview process that will be scheduled in late April or early May from 6:30-7:30pm at the Lydell Community Center.
- 5) Bay Volunteer Applicant will assist in the supervision of camps while on assigned field trips. Field trip hours may extend beyond selected volunteer hours.
- 6) Bay Volunteer Applicant should have a passion for youth and like to have fun!
