Dear Families and Community Members:

You are receiving this survey because the Whitefish Bay School Board is exploring options to update our facilities. **Your opinion matters, and your feedback will help determine whether we move forward with a referendum in April 2026.**

Whitefish Bay public schools have a strong tradition of excellence; we are proud to be among the highest achieving districts in Wisconsin. We believe our schools contribute to the high quality of life in this community and are crucial to maintaining strong property values.

While we address routine maintenance each year, all five buildings (built between 1918 and 1955) are aging. Building systems (such as HVAC, plumbing, and electrical) have exceeded their service life. Classrooms/support areas do not meet today's standards and have accessibility challenges.

To help develop options, we formed the **Facilities Advisory Committee (FAC)**, made up of community members, parents, staff, and students. **The process identified over \$325 million of possible projects.** Your feedback is essential in helping us decide what to do next.



Additional Analysis: Referendum support for each amount



Weighted support for *Definitely yes* and *Probably yes*:

\$325M: 0.30 (24%) + 0.70 (8%) = 12.8%

\$275M: 0.30 (30%) + 0.70 (12%) = 17.4%

\$225M: 0.30 (51%) + 0.70 (25%) = 32.8%

\$175M: 0.30 (63%) + 0.70 (39%) = 46.2%

\$125M: 0.30 (76%) + 0.70 (57%) = 62.7%

Smaller: 0.30 (85%) + 0.70 (77%) = 79.4%

Note: Survey results indicate a +/- 2.12% statistical margin of error

\$135.6M Referendum: What's Included?





What would be included in a \$135.6M referendum?



- **Building Renovations (\$67.9M) at Cumberland, Richards, High School and Lydell**

Focus Areas: Aging Infrastructure, Accessibility, Safety, and Security

- **Increase** - Accessibility, safety & security at building entrances
- **Improve** - Elementary drop off and pick up
- **Upgrade** - Fire and sprinkler systems to code
- **Update** - Plumbing and electrical systems
- **Replace** - Aging and unreliable HVAC systems

- **Construct New Middle School (\$67.7M)**

Focus Areas: Learning Environments, Aging Infrastructure, Accessibility, Safety, and Security

- **Flexible Learning Spaces** - Designed to enhance teaching best practices
- **Honor the Past** - Veterans Memorial integrated into the overall project plan
- **Minimal Disruption to Learning** - During construction of the new building

Note: The school district plans to contribute \$20.4 million of funding in addition to the \$135.6 million referendum which will be integrated into the projects listed above.




Construct a New Middle School (\$67.7M)



The Board explored a number of options to update the existing building, which is over 100 years old. Given its age, layout, and inflexible design, the cost to renovate is approximately the same as a new building.

Therefore, the School Board is recommending building a new middle school on the south side of Henry Clay Street (see image). The Veterans' Memorial Monument would be reestablished on or near its current site, and the tennis courts and parking lot would be relocated.

The School Board chose this option because it provides the best long-term investment in facilities, avoids disruption to teaching and learning, and provides the most design flexibility.




Finance and Funding





Public School Finance



Established in 1993, revenue limits set a maximum amount of revenue a public school district could raise through state general aid and property taxes. The maximum limit for a district can change based on membership and per pupil increases from the state. A district may only exceed the revenue limit through an approved exemption or by referendum.



Public School Funding

General school district revenues per pupil lag inflation by more than \$3,300 since 2009



Wisconsin public schools have not received an inflationary increase from the state since 2008-09 and received no per pupil increases in the 2021-22 and 2022-23 school years resulting in budget deficits in many districts across the state. Even with limited funding, costs continue to rise for school districts resulting in many schools needing to make significant cuts into their educational programs or having to pursue an operational referendum. This shortfall represents 21.5% less buying power compared to 2009.



After a decrease in enrollment during the COVID-19 pandemic, student counts have been steadily increasing over the last few years. Long-term projections for enrollment predict a slight decline over the next 15 years.




The tax levy rate for 2024-25 was \$5.92 for every \$1,000 of property value. Therefore, the calculation for this example would be \$419,300 (fair market value) multiplied by .00591581 (tax levy rate divided by 1,000) minus \$540.51 (school levy credit).

Total School Tax Levy History



After a slight decline in the total tax levy starting in 2020, the total levy amount for the Whitefish Bay school District has increased over the last few years due to a number of factors including the state budget, private school vouchers, and the final debt payments from the 2009 referendum. The total levy amount for Whitefish Bay School District for 2026 is less than the total amount levied in 2018.






We propose utilizing \$20.4 million from District funding for a strategic combination of:

- Fund 10 (General Fund) - \$6.9 million
- Fund 46 (Long-Term Capital Improvement Trust Fund) - \$10 million
- Fund 80 (Community Service Fund) - \$3.5 million

Referendum Amount: \$135.6 million

District Funding Amount: \$20.4 million

Total Project Amount: \$156 million

Note: Fund 46 can only be used on projects included in the long-term capital plan. Fund 80 can only be used on projects at Lydell School and Community Center, or for other community projects.

Preliminary tax impact estimates assume borrowing over a 21-year period at an interest rate of 5% to 5.25%. The District is scheduled to pay off the remaining debt obligations from the November 2009 referendum in 2026 and the impact of those final payments is included in these estimates. The current tax levy impact of the November 2009 referendum debt is \$57 per \$100,000 of property value.

Your Voice Matters: Referendum Resolution Question

Shall the School District of Whitefish Bay, Milwaukee County, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$135,600,000 for the public purpose of paying the cost of a district-wide school building and facility improvement project consisting of: safety, security, building infrastructure and capital maintenance improvements at Whitefish Bay High School, Cumberland and Richards Elementary Schools, and Lydell School and Community Center; construction of and site improvements for a new middle school to replace the existing middle school; acquisition of land; demolition of the existing middle school and repurposing the site for district and community use; and acquisition of furnishings, fixtures and equipment?
